ICSFT CONDEMNS USA AND ITS ALLIES IMPERIALIST WAR ON SYRIA

“A very sad day for the world, for the U.N., for its Charter which was blatantly, blatantly violated, and for the Security Council which has shirked its responsibilities. I would like to believe that we will not see a day that is worse than today,” he said.

This attack creates a breeding ground for terrorist groups like ISIS who are currently retreating and worsens the humanitarian situation in Syria, although the self-righteous and self-appointed watchdogs – USA, UK and France - are claiming humanitarian intervention for their illegal act of aggression.

This was the same propaganda that was used to oust Saddam Hussein that resulted in the creation of ISIS which we cannot afford to repeat that mistake in an era where terrorism affects us more than ever.

We must send a strong message that such illegal act of aggression is not acceptable despite who the aggressor is – the USA and allies should be held to the same standard of responsibility and accountability as per international norm. Every nation must set a precedent and denounce this act of aggression against a sovereign country before this reckless and politically sensationalized aggression becomes a trend and a threat to world peace and security.
