The peace has been disrupted by Israeli's unlawful and brutal allowance and use of live ammunition against the peaceful protestors. This allowance has occurred in violation to international human rights and humanitarian law.

Casualties to date include:

- 48 murdered peaceful protesters, most in cold blood by Israeli snipers
- at least 5,500 wounded and at risk of dying from their wounds

on Friday, April 27th alone

- 3 protesters were murdered
- 955 were injured

the casualties include

- journalists
- children
- human rights defenders, both women and men

ICSFT reprehends and condemns Israel and its Western backers, including the United States and United Kingdom, and the international community at large, including UN mechanisms that have not acted effectively, for allowing this massacre of innocent citizens while
