The International Council Supporting Fair Trial and Human Rights expresses its solidarity with all prisoners and detainees in the secret prisons in the south of Yemen. For over four years, the suffering of the people of the southern region of Yemen has still continued, by continue with violations of enforced disappearance, arbitrary detention and brutal practices of the United Arab Emirates unchecked.

The Council condemns inhumane and encroachment practices and all the violations of human rights principles against the Yemeni people, stressing that arbitrary detention and forced detention are a war crime and must be held accountability of the perpetrators.

It also calls upon the legitimate government to shoulder its legal responsibility towards the lives and safety of prisoners and detainees and to ensure that they enjoy their full legitimate rights.

According to a statement issued by the Southern Revolutionary Movement:

By Name, 118 detainees in prisons and the UAE occupation of in Hadramout without charges or even files!!!

Happening in the south, that the people of the South are detained and arrest, handed over in a formality manner to what is called the Yemen legitimacy, (in escaping the follow-up of international human rights organizations) ... actually, those who detain them, some of them complete their third year without charge or even include his name and his case in a file...It is the occupation of the UAE in the south through its tools.

Some detainees said, in particular and reliable, that they had been subjected to the ugliest practices Inhumane treatment and the most severe forms of torture, including physical and psychological torture, rape and enforced disappearance.

Some have not been sentenced or convicted, since two or three years ago. and some have got released decision from the public prosecutor for 10 months and are still being held, And on top those, Awad al-Dikil, Ali Baqtian and others.

Controls them lives, safety and dignity of the South people who are detained in their land by foreign men who do not have names (whose names are not disclosed to protect them from retaliation) they use the nickname to call.

There are more than 11 detainees without charge and no file!!! Before they were transferred, they were detained in what is known as the detention camp "Al Rayyan" ... Those are still for more than 13 days in hunger strike, and their health began to deteriorate, two of them refused to install "feeder" According to their comrades require the rapid intervention of the concerned authorities and human rights organizations, especially after The entry of two of them to the clinic in a bad condition, and they are Rawi Belaafir and Said Aladni ...

Al-Rayyan detainees are subjected to torture, like others in Al-Qasr, or Al-Rabwa, or Daba they are still in Al-Rayyan detained despite the fallacies that the occupation forces and their mercenaries are trying to achieve On the human rights committees. Where detainees are transported to Hangar at the airport terminal, and thrown the mud, stones and bags are thrown into the dormitories so that they look deserted and free of detainees.
