## American intervention in the internal affairs of the Bolivarian Republic of Venezuela

The United States of America continues inauguration itself in charge of the peoples and countries of the world, and continues its policy of intervention in the affairs of the internal states to serve their interests in all levels and all fields, Today, Intrusion itself into the Bolivarian Republic of Venezuela, and the president, Donald Trump, is rushing to publicly acknowledge his support for the coup by the President of the National Assembly Juan Guaidó by inauguration himself as acting interim president of the country, For accelerated by the united states as well the recognition of the illegality of President Maduro's government.

The International Council Supporting of Fair Trial and Human Rights considers the intervention of the United States of America in the internal affairs of Venezuela as a serious threat to international peace and security in the region and deprives the Venezuelan people of their legitimate and inherent right to determine their fate, As that The American presence in Venezuela will threaten the legitimacy of the elections that are supposed to be the political solution Of the crisis in Venezuela through its declared support to Juan Guaidó, who in turn rejected the call for dialogue provided by President Nicolás Maduro, calling it a call for formal dialogue, and this evidence of his dependence on America's support for him and preference of America instead of the interest of the country.

The policy of America's intervention in the internal affairs of the Republic of Venezuela is considered as a clear and flagrant violation of the United Nations Declaration, it is not permissible to intervention in all its Types in the Internal Affairs of States No. 36/103 of 9 December 1981, which affirms, that no direct or indirect interference should be exercised, In the internal and external affairs of any other State, and all States must not threaten or use force against the sovereignty, political independence or territorial integrity of other States.

The United States must therefore bear in mind that peace and security are based on democracy and that the people have their fundamental right to self-determination. The sovereignty and right of States to manage their natural resources, irrespective of their political, economic or social systems or levels of development, must be respected.

The only major solution to solving the internal crisis in Venezuela is to hold fair elections where the voice of the people is the decisive decision in the country's self-determination, and ending of any interference in the internal policy of the state that would reach military intervention or force the people to have a president which chosen by the United States of America, to exacerbate the crisis from Within Venezuela to threaten the security of neighboring areas and cause the displacement and displacement of the country's indigenous people.

The current President of the Bolivarian Republic of Venezuela, Nicolás Maduro, is the legitimate President, the decision-maker and representative of the Venezuelan people until the people decide in their elections the contrary. and we assure, the people not the United States of America.
