United Kingdom and France, became known by all, despite of their claiming that they are committing their responsibilities and investigating the facts, they rejected the draft UN Security Council Resolution Submitted by Russia "to support the dispatch of investigators from the International Chemical Weapons Control Agency, to the location of the supposed attack in Douma, They have launched an illegal tripartite aggression on the Syrian territory and violated the sovereignty of the Syrian state and until today, they have not saw the world what the achievements of that aggression, only the repeated speech about emphasis that Syria possesses chemical weapons.

Israel was not far from its participation in the war crimes in the war against Syria, the victories of the Syrian Arab Army and the awareness of the Syrian people for the plot of the planned by the major countries to destroy his country, revealed the entry of the Zionist entity and its supporters in the confrontation in a direct way, after he was disguised behind his terrorist tools, it has launched several raids repeated air strikes have killed scores and destroyed many of the country's infrastructure.

The occupation authorities also continue to exercise arbitrary detention against the people of the occupied Golan against the backdrop of their opposition to the occupation and expose its illegal practices and expose its settlement policies and support to terrorist groups in the area of Separation zone and the vicinity region, to find conditions to help perpetuate its occupation of the Syrian Golan.

The International Council for the Supporting Fair Trial and Human Rights considers it a shame today to continue these violations and war crimes against the Syrian Arab Republic and impose economic sanctions on its people, which led to the deterioration of living conditions and became a barrier to the reconstruction of the country in the hands of its people despite the wounds after being destroyed by terrorism that spread in the country with the support of those planned and supportive States.

The Council calls for a comprehensive investigation into all war crimes committed by the terrorist groups against the Syrian people over nine years and the accountability of those who supported them with money and weapons. The Syrian blood that has flowed there, has diverted the whole world, not only Syria, from the dangers of destructive terrorism. We believe that it is time to calculate ...

States must also put an end of Intervention in Syria internal policy, with stressing that in accordance with the Charter of the United Nations, no State has the right to intervene directly or indirectly in sovereign Member States and for any reason in internal and external affairs. The Security Council must see things with the eyes of the Syrians alone and not allow the arrogance of the United States and its allies to continue to destroy States unchecked.

It is time to end the suffering that penetrated the hearts of the Syrians and to take what is necessary today to establish an independent and impartial international mechanism to investigate, condemn and punish the crimes of the United States of America on the Syrian territory and to condemn its blatant and their interference under the name of the international coalition without the consent of the Syrian state and the Security Council.

The Council is also deeply concerned about the suffering of the population in the occupied Syrian Golan and that the human rights there continue to be violated daily, with the emphasis that Israel's decision to impose its laws, jurisdiction and administration in the occupied Syrian Golan is absolutely null, and void and has no international legal effect on the basis of Security Council resolution 497 (1981) of 17 December 1981.

Syria has today won over terrorism and wreaked the world from its woes and , and today only the Syrians have the right to decide the future of their country and they have agreed to rewrite their constitution or revise it with their own hands, to realize the world that the strong link of the Syrian trio (the people, the leadership and the army) today destabilized the unilateral policy
