The Son Of Professor Hassan Mushaima Resumes The Protest In Order To Save His Father



On charges of freedom of opinion and expression, he was sentenced life imprisonment in the case known an issue of symbols, Mr. Hassan Mushaima has been detained since 2011

In a very bad conditions, which do not enjoy any humanitarian and moral standards, and in a policy aimed at humiliating and insult the prisoners of conscience and political activists, Mr. Hassan Mushaima is still being held in bad health in Jaw prison, which is known by its bad reputation of abuses which have exceeded its limits of Rails to reached to the world and the United Nations.

The political and moral principles of Mr. Hassan Mushaima led him to the expression of his opinions, claiming for a democratic transformation, which guarantees the Bahraini people the right to self-determination and guarantee a free and dignified life. he believed, that his country's accession to the International Covenant on Civil and Political Rights can enabled it to respect that, but the price was to face the judgment of life sentence.

Mr. Mushaima suffers from uncountable countless chronic conditions, including cancer, diabetes, high blood pressure and gout, and his condition requires regular examinations. Despite of that, the prison authorities have continuously restricted the process of carrying out these very important tests, restricting his access to medicines and depriving him of the right to treatment.

Despite of all the appeals from human rights organizations and UN bodies for the immediate release of Mr. Hassan Mushaima, and when his son the activist Ali al-Mushaima earlier on hunger strike to provided treatment to him, but, he was not hearded by Bahrain authorities.

Today and every day it renewed and will renew those demands until they are implemented, and this is what confirmed by Ali Mushaima in a tweet published on his Twitter account:



Stressing the existence of the intention to liquidate his father Mr. Hassan Mushaima, where the deprivation of treatment is a crime, against a man aged 71, and he is at the ninth year in prison unjustly and aggressively.

The International Council Supporting Fair Trial and Human Rights is in a solidarity with Ali Mushaima in his new step towards for the release of Mr. Hassan Mushaima and his right to treatment and affirms his priority in demanding and fully supporting for all the human rights stipulated in the Universal Declaration of Human Rights.

The Council affirms that the actions of the authorities in Bahrain in dealing with Professor Hassan and all prisoners of conscience are a flagrant violation of the International Covenant on Civil and Political Rights and the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, and the International Covenant on Economic, Social and Cultural Rights. In addition, Bahrain does not adhere to the United Nations Standard Minimum Rules for the Treatment of Prisoners (the Nelson Mandela Rules), which are required to provide adequate conditions to ensure that prisoners enjoy their full rights.

We renew our demand on the Bahraini authorities to immediately release all detainees, including Professor Hassan Mushaima, as his detention based on his right to express his opinion is illegal and does not comply with any standards of fair trial. We also demand that he be granted the right to treatment. We hold the Bahraini authorities fully responsible for the health and life of the fighter Hassan Mushaima.
