In a step far away from the humanity and without the knowledge of the families of the victims, the Interior Ministry announced on Tuesday, April 23, 2019, the Execution of death penalty of 37 Saudi citizens between of them some under ages and a Shiite cleric on charges of Formatting what they described terrorist cells, and agitation of chaos, Where Saudi Arabia had accused those whom has death penalty, charges of Communication with hostile external parties and attack Security headquarters.

But the reality conceals behind it great hatred, and boundless racism towards the Shiite community, the molds of charges which they can use with someone to reach to the gallows, are ready for every dissenting or Shiite person, only the names are different, that is why the Saudi authorities did not disclose the circumstances of the trials and evidence obtained to convict some of the accused.

The Judgments in Saudi Arabia follow sects and not laws and legislation. There is no fair trial, no hard evidence, not even the logic and the human. Provisions are taken secretly and after execution they announce about it to the public, without any sergeant or arbiter, and who can say no to Mohammed bin Salman The main instigator of that aggressive.

Mohammed bin Salman committed war crimes against the Yemeni people and killed in cold blood the Saudi opposition Jamal Khashoggi. And he arrested The women and allowed his forces to commit the worst forms of torture and rape, and many more, yet we have not heard any effective international action to stop him from continuing his crimes.

Despite the fact that he is the first accused of the international killing of Khashoggi, but the impunity of him and the Inaction of the international community to hold him accountable, and buying him for people who guarantee his peace by billions of dollars, and his transfer between countries to threaten security and peace Smoothly, which make him had the possibility to execute the death sentence in a cool and without fearless manner against these innocent people.

The continuation of the Saudi authorities by Methodology policy against women and religious minorities, the price will be paid by many citizens after those who were executed. In 2018 Saudi Arabia carried out 148 executions, 59 of them for non-violent crimes. Since the beginning of this year 104 executions. and Tomorrow hide more than that, where as there are thousands of opponents detained in Saudi prisons waiting for their verdicts.

International Council Supporting Fair Trial and Human Rights strongly denounce this immoral crime against 37 Saudi citizens with unfair trials, and stresses the needful to investigate on this criminal act by UN bodies under the supervision of the Special Rapporteur on extrajudicial executions. Saudi Arabia has no right to deprive its citizens of the right to life. The right that God has given to human cannot be loot it for any reason.

We were expected, that the names of Maher Al motreb or Salah Al-Tabaiqi or Saud al-Qahtani or Ahmad al-Asiri, despite the recognition of the highest levels of Saudi Arabia authorities to kill journalist Jamal Khashoggi is present in the judgments. But the 37 martyrs are seen by Saudi Arabia the most dangerous and they threat their security by their peaceful claiming their rights. This confirms that the aim of the executions is to

The Council affirms that the Saudi authorities and Mohammed bin Salman are not the only ones responsible for this crime. Everybody or in the international community that has Inaction from its role in protecting those innocent people and protect their rights is also a partner in this death penalty.

ICSFT call on to isolate Mohammed bin Salman internationally and limit his political activity, which is a threat the international peace and security, and put an end to the provisions of the Saudi authorities outside the law and force them to abolish the death penalty fully and surely without any exceptional cases where Saudi Arabia finds a way to return to its implementation of death penalty.

We also appeal to all countries that can hand over Mohammed bin Salman to the International Criminal Court, and Do not be complacent in this matter, which can save the lives of thousands of opponents who await their unknown fate so far ...
